By signing this agreement, I acknowledge and accept the terms and conditions regarding my use of equipment from Hayling WaterSports and Fishery Creek. I understand that I and any members of my group must always remain within Fishery Creek unless participating in a guided tour.

I agree to use the supplied dry bag or waterproof phone case, personal flotation device (PFD), leash, and quick release belt with each stand-up paddleboard (SUP) or kayak as appropriate.

I understand that my credit or debit card will be charged the full amount of my rental agreement prior to the land briefing, and that payment is required in advance of equipment use.

I am responsible for returning all equipment in the same condition as received, reasonable wear and tear excepted. I agree to pay in full for any repairs or replacement costs if the equipment is damaged or lost during my rental period. I acknowledge that stand-up paddleboarding (SUP) and kayaking involve inherent risks and dangers.

I accept full responsibility for my own safety and the safety of any group members for whom I am signing. I agree to assume all risks associated with the use of the equipment, whether foreseen or unforeseen, including those arising from the fault or negligence of Hayling WaterSports, Fishery Creek, or any of their suppliers or employees. This includes any loss or damage to personal items while I or my group are on the water.

I understand that while Hayling WaterSports checks the condition of all equipment before and after use, they do not guarantee the fitness or suitability of the equipment for any particular purpose. Recommendations regarding equipment are provided as guidance only.

To the fullest extent permitted by law, I hereby release Hayling WaterSports, Fishery Creek, and any of their suppliers or employees from all liability for any harm, injury, damages, or accidents that may occur to myself, any member(s) of my group, or the equipment I borrow.

I confirm that I am physically fit and capable of safely using the equipment. I have undertaken any necessary medical examinations to ensure my fitness for these activities.

I understand that both the RNLI and UK Coastguard recommend that all paddlers wear an approved personal flotation device (PFD). Hayling WaterSports requires all customers to always wear the provided PFD while on the water.

I acknowledge that at least one member of my party must be over the age of 18 and must always accompany the group on the water. Identification may be required to verify age and identity. I have read and fully understand the contents of this agreement before signing and realise that it covers the entire group for whom I am signing.
