## HISPEC TERMS AND CONDITIONS

#### GENERAL

These conditions apply to all supplies of goods and services by HISPEC ELECTRICAL PRODUCTS LTD and shall prevail over any other terms and conditions referred to in the purchase order unless agreed in writing between the parties. Lamps are guaranteed to their expected life show separately.

#### **TERMS**

Settlement of all accounts is normally required in full 30 days after the end of the month in which the goods are invoiced (Ex Feb). HISPEC ELECTRICAL PRODUCTS LTD retains the right to charge interest of 2.5% above that of HISPEC ELECTRICAL PRODUCTS LTD banker's rate from the due date of invoice for late payment. New clients requiring urgent delivery on their initial order should arrange for payment on a pro forma invoice.

#### RETENTION OF TITLE AND ALL MONIES CLAUSE

The goods will remain the property of HISPEC ELECTRICAL PRODUCTS LTD until ALL MONIES are paid for in full. The full risk of the goods will pass to the purchaser upon receipt of the goods. HISPEC ELECTRICAL PRODUCTS LTD retains the absolute right to discontinue delivery if the customer defaults on payment.

However, notwithstanding delivery and the passing of risk in the goods, title and property in the goods, including full legal and beneficial ownership, shall not pass to the buyer until the seller has received in cash or cleared funds payment in full for all goods delivered to the buyer under this and all other contracts between the seller and the buyer for which payment of the full price of the goods thereunder has not been paid. The company has a responsibility to advise HISPEC ELECTRICAL PRODUCTS LTD of any change to the Company name, address or Directors.

Payment of the full price of the goods shall include the amount of any interest or other sum payable under the terms of this and all other contracts between the seller and the buyer under which the goods were delivered.

Hispec Electrical Products Ltd reserves the right to enter the premises in order to repossess the goods, and this will not be considered as trespassing.
